To be eligible to apply, applicants must have worked at Ohio State for a minimum of two continuous years. PPCW membership is open to Ohio State employees of all genders and is inclusive of trans women and non-binary individuals.

PPCW meetings are typically monthly on a Monday or Tuesday from 12:30-2 pm. Applicants should notify their supervisors that they are applying to PPCW because, if you are appointed, the person to whom you report will need to be supportive of you contributing time to the council. A letter of recommendation is NOT necessary.

This application must be completed in one sitting, as data will not be saved for future sessions. Providing a resume, CV, or biosketch is optional, but please have this document available if you plan to upload it.
